Section 4 - First Aid Measures

General Information: You should call The Poisons Information Centre if you feel that you may have been poisoned, burned or irritated by this product. Section 6 - Accidental Release Measures

Accidental release: Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses. Wear protective clothing including impervious gloves and safety goggles. All skin should be covered. Thoroughly launder protective clothing before storage or re-use. Handling: Keep exposure to this product to a minimum, and minimise the quantities kept in work areas. Storage: Store in cool, dry area removed from foodstuffs. Ensure containers are labelled, protected from physical damage and sealed when not in use. Do not allow to come into contact with water either from rain, condensation or the surface on which it is stored. Bagged fertilisers should be stored under cover and out of direct sunlight. If stacking is necessary, bulk bags should be stored in a stable manner, preferably in a pyramidal style. The pallet Capacity Rating (Design Weight) should not be exceeded on the bottom tier for other packs. High stacking should be avoided as pressure promotes caking. Store away from farm
