### **Section 4 - First Aid Measures**

### **General Information:**

**Skin Contact:** Quickly and gently brush away excess particles. Wash gently and thoroughly with water (use non-abrasive soap if necessary) for 10 minutes or until chemical is removed. If irritation persists, repeat flushing and obtain medical advice.

**Eye Contact:** Quickly and gently brush particles from eyes. Immediately flush the contaminated eye(s) with lukewarm, gently flowing water for 15 minutes or until the product is removed, while holding the eyelid(s) open. ### Section 6 - Accidental Release Measures

**Accidental release:** In the event of a major spill, prevent spillage from entering drains or water courses. Wear full protective chemically resistant clothing including eye/face protection, gauntlets and self contained breathing apparatus. See below under Personal Protection regarding Australian Standards relating to personal protective equipment. Suitable materials for protective clothing include no specific manufacturer recommendations. Use impermeable gloves with care. # Section 10 - Stability and Reactivity

**Reactivity:** This product is unlikely to react or decompose under normal storage conditions. However, if you have any doubts, contact the supplier for advice on shelf life properties.

**Long Term Exposure:** Long term inhalation of high amounts of any nuisance dust may overload lung clearance mechanism. No data for health effects associated with long term inhalation.
