#### 4. FIRST AID MEASURES

### 6. ACCIDENTAL RELEASE MEASURES

#### SMALL SPILLS

#### LARGE SPILLS

Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal. #### 7. HANDLING AND STORAGE
